Dear Sir,

As per decision of the Equivalence Committee of erstwhile UGC final sanad "Shahadatul Almiya Fil Uloomal Arabia wal Islamia" awarded by five Wafaq-ul-Madaris, Tanzeem-ul-Madaris, Rabita-ul-Madaris and five individual Madaris listed below are accepted by Higher Education Commission as equivalent to M.A Arabic/Islamic Studies for the purpose of teaching Arabic and Islamic Studies in Colleges and Universities and for pursuing higher studies. The approved Madaris are as under:

1. Wafaq-ul-Madaris Al-Arabia, Markazi Office Gordon Town, Sher Shah Road, Multan.
2. Tanzeem-ul-Madaris Alhe Sunnat, Jamia Naeemia, Ghari Shaho, Lahore
3. Wafaq-ul-Madaris Al-Salfia, Hajiabad Post Code 38600, Faisalabad.
4. Wafaq-ul-Madaris Shia, Jamia-al-Muntazar, H. Block, Model Town, Lahore.
5. Rabita-ul-Madaris Al Islamia Mansoor Road, Lahore.
6. Jamia Islamia Minhaj-ul-Quran, 366 Model Town, Lahore.
7. Jmia Taleemat-e-Islamia, Sargodha Road, Faisalabad.
8. Jamia Ashrafia, Feroz Pura Road, Lahore.
9. Darul Uloom Mohammadia Ghousia Bhera Distt. Sargodha.
10. Darual Uloom, Korangi Greek, Karachi.



For recognition of Final Sanad "Shahadatul Almiya Fil Uloomal Arabia wal Islamia", the holders are required to possess following Certificate/Asnad:

- Middle School Certificate	8-year of study
- Shahadatul Sanvia Aama:	2-year of study
- Shahadatul Sanvia Khasa:	2-year of study
- Shahadatul Alia:	2-year of study
- Shahadatul Almiya:	2-year of study


Thus, making total period of study as **16-year** i.e. at par with the duration of study for Master's degree in Arabic or Islamic Studies.

The Commission, however, is facing problems in ascertaining the genuineness of Asnad and determining their equivalence because of the following:

- (i) that students admitted for Sanad "Sanvia Aama" are admitted without having passed Middle School Certificate or 8th class from school/s in main stream.
- (ii) that in majority of cases period of study between any two Asnad is less than 2-year. Thus, making total period of study less than 16-year, which is prerequisite for consideration of grant of equivalence.
- (iv) number of cases have been repeated, where holders of 'Asnad' did not attend the main or principal seat of Wafaq or Tanzeem or Rabit ul Madaris or Individual Madaris listed above, rather have obtained 'Asnad' through affiliated Madaris.

Therefore, in order to avoid any chance of getting 'Deeni Asnad' through fake or bogus institutions, you are requested to provide this office a list of affiliated Madaris of your Wafaq/Tanzeem or Rabit-ul-Madaris.

The list of approved institutions is required to reach undersigned by **May 30, 2004** failing which it may not be possible to 'Attest' the Asnad and to consider these for 'Equivalence'.
